Old Business: None discussed.

New Business: The Council discussed procedure for Resolution 2021-01 titled A Resolution of the City of Austin Adopting a Fiscal Plan and Establishing a Definite Policy for Services. Josh Stigdon explained to Council the steps involved with the Resolution. A Public Hearing for Resolution is scheduled for March 9, 2021.

Resolution 2021-02: A Resolution to Extend Federal Emergency Paid Sick Leave and Emergency Family and Medical Leave Provisions Related to COVID-19. Dewayne White made the motion to approve. Brandon Stagnolia seconded the motion. Motion passed 5-0.

Ordinance 2021-02: An Ordinance Amending Rates and Charges for the Use of and Services Rendered by the City of Austin, Indiana, Sewage Works was introduced. Dewayne White made the motion to approve by title only on first reading. Jimmy Turner seconded the motion. Motion passed 5-0.

Ordinance 2021-03: Ordinance To Establish A CEASE Local Grant Fund For The City of Austin. Joe Smith made the motion to read by title only on first reading. Dewayne White seconded the motion. Motion passed 5-0. Jimmy Turner made the motion to approve Ordinance 2021-03 on first reading by title only. Dylan Baker seconded the motion. Motion passed 5-0.

Mayor Hawkins discussed with Council the option of placing a recyclables container at the Street Department. The container would be available for citizens to drop off recyclables once a month. He informed Council that he had spoken with Estes Waste Solutions concerning costs. Rental fee for container is \$90.00 monthly with a tipping fee of \$200.00 about every 3 months. Brandon Stagnolia made the motion to approve recycleable container and fees. Dewayne White seconded the motion. Motion passed 5-0.


