Claims: Brandon made a motion to approve the claims from March 9, 2021 through April 13, 2021, seconded by DeWayne. Motion passed 5 – 0.




Jimmy made a motion to adjourn at 6:43 pm, seconded by Dylan. Motion passed 5 – 0.




