Roger Hawkins, Joe Smith, Brandon White, Dewayne White, Dylan Baker and Jimmy Turner were all present.


**Minutes:** Brandon made a motion to approve the minutes from the July 13, 2021 meeting, seconded by Joe. Motion passed 5 – 0.

**Claims:** Dewayne made a motion to approve the claims from July 13, 2021 through August 10, 2021, seconded by Joe. Motion passed 5 – 0.




**Adjournment:** Jimmy made a motion to adjourn at 7:09 pm, seconded by Dewayne. Motion passed 5 – 0.




