**Minutes:** DeWayne made a motion to approve the minutes from the August 10, 2021 meeting, seconded by Joe. Motion passed 5 – 0.

**Claims:** Joe made a motion to approve the claims from August 10, 2021 through September 13, 2021, seconded by Dylan. Motion passed 5 – 0.

**Old Business:** No old business.

**New Business:** Chris Fugate, Clerk Treasurer, read Resolution 2021-16, Local Match for Community Crossings Grant. Jimmy Made a motion to approve Resolution 2021 -16, seconded by DeWayne. Motion passed 5 – 0. Josh Stigdon, City Attorney read Resolution 2021 -17, Request for Proposal for Solar project. Joe made a motion to approve Resolution 2021-17, seconded by Dylan. Motion passed 5 – 0. Josh then read Ordinance 2021 – 12, Amending the Park Rules. DeWayne made a motion to approve the first reading of Ordinance 2021 -12, seconded by Jimmy. Joe made a motion to suspend the rules on the reading of Ordinance 2021 – 12, seconded by Jimmy. Motion passed 5 – 0. Brandon then made a motion to pass Ordinance 2021 -12 on the 2<sup>nd</sup> and final reading, seconded by DeWayne. Motion passed 5 – 0. Josh then talked about Ordinance 2021 -13, Rezoning Ordinance. Joe made a motion to approve Ordinance 2021 – 13, seconded by Dylan. Motion passed 4 – 1 with Jimmy voting no. Josh talked about Resolution 2021 – 18, Accepting Mac Drive as a City Street. Brandon made a motion to approve Resolution 2021 – 18, seconded by Joe. Motion passed 5 – 0. Mayor Hawkins informed the council that city hall's parking lot needed to be sealed and restriped. He had obtained a quote from Salyers Seal Coating & Construction for the amount of \$1350.00. Joe made a motion to approve the quote for the sealing and stripping of the parking lot, seconded by Brandon. Motion passed 5 – 0. Chris asked the council, on behalf of the parks board, to declare the four wheeler excess. DeWayne made a motion to declare the parks board four wheeler excess, seconded by Joe. Motion passed 5 – 0. The council then discussed using the ARP money to give all city employees who are currently employed premium pay for essential work. Jimmy made a motion to give all city employees, elected officials and city attorney \$2500.00 for their continued work through the ongoing Covid pandemic, seconded by DeWayne. Motion passed 5 – 0.


**Adjournment:** DeWayne made a motion to adjourn at 7:06 pm, seconded by Joe. Motion passed 5 – 0.
