

COMMON COUNCIL OF THE CITY OF AUSTIN, INDIANA

ORDINANCE NO. 2022-06

TO APPROPRIATE FROM THE ARP CORONAVIRUS LOCAL FISCAL RECOVERY FUND FOR PURPOSES THAT FULFILL THE INTENT OF THE AMERICAN RESCUE PLAN ACT IN AID OF THE CITY OF AUSTIN'S RECOVERY FROM THE EFFECTS OF THE COVID-19 EMERGENCY

WHEREAS, on May 10, 2022, in Resolution 2022-R-___, the Common Council adopted the American Rescue Plan Act Community Investment Plan (Version 2.0) ("ARPA Plan Version 2.0"), which details additional ARP Fund expenditures and shall be amended from time to time as and when the Common Council approves additional appropriations from the ARP Fund for the benefit of the community; and

WHEREAS, the Administration hereby brings this request for appropriation of the amounts specified herein for the purposes set forth in the ARPA Plan Version 2.0, and for appropriation of the amounts specified from the ARP Fund to the identified funds for additional expenditures the City will make to aid the community's recovery from the COVID-19 pandemic.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY THE COMMON COUNCIL OF THE CITY OF AUSTIN, SCOTT COUNTY, INDIANA, THAT:

SECTION 1: For the expenses of the City, the following additional sums of money are hereby appropriated and authorized for the purposes herein specified, subject to the laws governing the same:

- A. \$182,600.00 from the ARP Coronavirus Local Fiscal Recovery Fund.
- B. \$3,000.00 from the ARP Coronavirus Local Fiscal Recovery Fund.

SECTION 2: The Common Council has adopted by Resolution 2022-R-___ the ARPA Plan Version 2.0, which details the proposed expenditures from the ARP Fund. The ARPA Plan Version 2.0 shall be amended from time to time as and when the Common Council approves additional appropriations from the ARP Fund for the benefit of the community.

SECTION 3: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 4: If any section, subsection, paragraph, sentence, clause or phrase of this Ordinance is declared unconstitutional or invalid for any reason, such decision shall not affect the validity of the other remaining parts.

SECTION 5. This Ordinance shall be in full force and effect from and after its passage, approval, and publication according to law.
