by Commissioner Goodin.


4. PRESIDENT'S REPORT

Mayor Hawkins provides an update on the purchasing of the real estate identified a. as Parcel Numbers 72-03-36-420-015.000-003, 72-03-36-420-019.001-003, and 72-03-36-420-020.001-003 owned by David and Barbara Lucas in an amount

above the average of two appraisals, not to exceed \$75,000. Mayor Hawkins

advised that the owners are willing to sell at \$75,000 and that owners state that

they have documents showing no encroachments or environmental concerns with



the property. Mayor Hawkins to get the documents seller has and to share with
City Engineer for review and comment before moving forward with the purchase.
b. President Buchanan advises that a purchase agreement has been executed between
Tex Murphy and a developer on Main Street that is anticipated to be a Dollar
Tree. The developer's plans would require the closure of 6th Street and the platted

alleyway. Attorney Stigdon advises that a survey should be done to establish a

legal description for the area to be vacated and that a petition to vacate would

need to be filed with the City. Mayor Hawkins to have an 8-1-1 request submitted


for the alleyway between Main Street and Cherry Street to figure out what

Audrey/Linden Subdivision. Developer is working on project with USDA


