

ORDINANCE 2017- 05

**AN ORDINANCE APPROVING THE ADDITION OF
STOPS SIGNS ON WADE STREET IN THE CITY OF AUSTIN**

WHEREAS, a review of traffic by the Austin City Police Department indicates that it is necessary for safe traffic control and flow on Wade Street in the City and that stop signs should be erected for north and south bound traffic on Wade Street at its intersection with Rural Street and South Street;

WHEREAS, it would be in the best interest of traffic safety and control for said Stop signs to be erected as set forth above; and

WHEREAS, the Board of Public Works and Safety heard testimony on this issue at its meeting on June 12, 2017 and passed a recommendation unanimously to this Council that said stop signs be placed as set forth above.

THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF AUSTIN that:

Section 1. Pursuant to the authority of I.C. 9-21-1-3 and I.C. 9-21-4-11, stop signs shall be placed for both north and south bound traffic on Wade Street at its intersections with Rural Street and South Street.

Section 2. The Board of Public Works and Safety is hereby authorized to erect such signs and other traffic control devices as may be necessary to implement the intent of this Ordinance.

Section 3. Anyone failing to stop in accordance with the sign herein provided shall be guilty of a Class D infraction which carries a penalty of up to Twenty-Five Dollars (\$25.00).


Section 4. This Ordinance shall become immediately effective upon its adoption by the Common Council, signature of the Mayor, enrollment in the book of Ordinances, publication of notice as required by law, and posting of the stop signs at said intersection.

Section 5. Any Ordinance in conflict with this Ordinance is hereby repealed.

PASSED AND ADOPTED by the Common Council of the City of Austin, Indiana on the 10th day of July, 2017 by a vote of 5 to 0.


