ORDINANCE 2017- 06

AN ORDINANCE REVISING THE FEES FOR THE COST OF WASTE AND REFUSE COLLECTION AND REMOVAL WITHIN THE CITY OF AUSTIN

WHEREAS, the City of Austin operates its own trash and refuse collection for the benefit of its residents and desires to continue to do; and;

WHEREAS, the equipment necessary to provide adequate service to the City is expensive to maintain and at some point will need to be replaced;

WHEREAS, the City is aware of the burden any price increase may have on the citizens of the City, but must weigh that burden against the efficiency and desirability of continuing to self-provide trash services;

WHEREAS, the City has determined that an increase in the fees for trash service is necessary.

THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF AUSTIN that the Austin City Code § 50.10 shall be revised as follows:

The monthly fee for trash collection shall increase to Fifteen Dollars (\$15.00) per month effective with the August billing cycle. Each year hereafter, the monthly fee shall increase Twenty-Five Cents (\$0.25) with the August billing cycle.

Rates for the collection of trash from each dumpster will be as follows effective with the August billing cycle:

- (a) Forty-five dollars (\$45.00) per month for collection of trash from dumpsters no more than two cubic yards in size;
- (b) Fifty dollars (\$50.00) per month for collection of trash from dumpsters no more than three cubic yards in size; and

(c) Sixty-five dollars (\$65.00) per month for collection of trash from dumpsters more than three cubic yards in size.

Each year hereafter, the dumpster fees shall increase One dollar (\$1.00) with the August billing cycle.
