- -Requesting a loan be obtained to purchase a new police car, stating usually grant funds were used but the USDA has not released any funds because of a delay in their budget. Joe Smith made a motion to approve the loan seconded by Brandon White motion passed 4-0
- -Making Heritage Engineering Flood Plain Administrator due to new policies and training required to hold this position with the City. Attorney Stigdon stated he would work on this and it would be on next months' agenda.

Ordinance 2024-OR-02 Credit Card Policy (1st Reading only)

Attorney Stigdon read ordinance 2024-OR-02. Brandon White made a motion to approve the first reading seconded by Staci Mullins motion passes 4-0
