COMMON COUNCIL OF THE CITY OF AUSTIN, INDIANA ORDINANCE NO. 2025-OR-06

AN ORDINANCE OF THE COMMON COUNCIL OF THE CITY OF AUSTIN,

INDIANA, ADOPTING THE 2025 COMPREHENSIVE PLAN

WHEREAS, Indiana Code § 36-7-4-500 et seq. authorizes a unit of local government to adopt a comprehensive plan to guide the future development and growth of the community; and

WHEREAS, the City of Austin Plan Commission has conducted a study and prepared a proposed updated Comprehensive Plan reflecting the current conditions, community vision, goals, and recommendations for land use, transportation, housing, infrastructure, economic development, and public services; and

WHEREAS, after due notice and in accordance with Indiana law, the Plan
Commission held a public hearing on the proposed Comprehensive Plan and has recommended
its adoption by the Common Council of the City of Austin; and

WHEREAS, the Common Council finds that the proposed Comprehensive Plan promotes the public health, safety, and welfare of the residents of the City of Austin and is in the best interest of the City and its future development;

NOW, THEREFORE, BE IT ORDAINED by the Common Council of the City of Austin, Indiana, as follows:

ADOPTION. The 2025 Comprehensive Plan for the City of Austin, Indiana, a copy of
which is attached hereto and incorporated herein by reference as Exhibit "A", is hereby
adopted as the official Comprehensive Plan for the City pursuant to Indiana Code § 36-74-500 et seq.

- 2. <u>SUPERSEDING PRIOR PLANS</u>. All previously adopted comprehensive plans, including all components, amendments, and supplements thereto, are hereby repealed and superseded in their entirety by the 2025 Comprehensive Plan adopted herein.
- 3. <u>EFFECT</u>. This Comprehensive Plan shall guide the decision-making of the City of Austin, its boards, commissions, and departments in matters related to land use, planning, development, and infrastructure, and shall supersede any prior versions of the City's comprehensive plan.
- 4. <u>FILING AND AVAILABILITY</u>. A copy of the adopted Comprehensive Plan shall be kept on file in the office of the Clerk-Treasurer and be made available for public inspection during regular business hours.
- 5. <u>SAVINGS CLAUSE</u>. If any section, subsection, sentence, clause, or provision of this Ordinance or the attached Comprehensive Plan shall be declared invalid by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance or the Plan, which shall remain in full force and effect.
- 6. <u>EFFECTIVE DATE</u>. This Ordinance shall be in full force and effect from and after its passage, approval, and publication as required by law.
